

Ready by Five Early Childhood Millage, Navigation and Outreach Services – Request for Approval

Action Requested: Recommend to Kent County Board of Commissioners to approve a total of \$2.4 million in Ready by Five Childhood Millage funds for alocation to Navigation and Outreach Services.

Summary of Request

The allocation amounts for Outreach and Navigation Services were recommended by the Ready by Five Resident Proposal Review Board on July 17, 2019. Recommendations were approved by the First Steps Commission on July 25, 2019.

The amount of \$2.4M will be allocated within contracts that will begin October, 2019 and run through December, 2021 (27-months) to the following four (4) organizations:
