

#### Ready by Five Early Childhood Millage Resident Proposal Review Board Funding Allocation Summary

#### Proposed for Approval to the First Steps Kent Board of Commissioners

**September 30, 2021** 

The Ready by Five Resident Proposal Review Board (RPRB) met September 20-23, 2022, to review 23 proposals submitted under the following RFP opportunities:

- Healthy Development Healthy Expectant and New Parents
- Healthy Development Developmental and Social Emotional Screenings and Connection
- Healthy Development Healthy and Safe Home Environment
- Healthy Development Niche Parenting Support
- Healthy Development Network Training Lead
- Parent Education and Support -Translation and Interpretation provides services for families engaged in all Ready by Five funded programs.
- Technology request for all programs funded by Ready by Five to purchase computers costing above \$1,000 for staff working in Ready by Five funded programs.

On September 23, 2022, the RPRB recommended allocating \$1.6M that will fund 19 additional proposals. This is in addition to previous RPRB recommendations to continue funding 29 programs currently under contract through December 31, 2023.

Accompanying these recommendations are expenses related to the data warehouse and third-party evaluation services underway to measure the effectiveness and accountability of the programs funded by the Ready by Five Millage. The total allocation for January 1- December 31, 2023, is \$9,838,370.00

Recommendations represent a 12-month calendar year. As Kent County transitions to an October 1 fiscal year schedule, funds for this 12-month period will be contractually committed for the first nine months (January 1 – September 30). Funds committed that fall into the next fiscal year (after October 1) will be contingent on both contract performance and approval by the Kent County Board of Commissioners and will include the remining three months (October 1 – December 31) of the calendar year. All contracts will transition to one contracting timeline to align with the October 1 fiscal year beginning in 2024.

All expenses included below were reviewed by the Resident Proposal Review Board in September 2022. The breakdown of funding recommendations FY 2023 are as follows (Please note: the allocations FY 2022 are provided for comparison purposes):

### Service Category 1: Outreach and Navigation

Within the provider network, partners funded as Outreach and Navigation providers are working towards increasing multiple entry points for families with young children and working with families to identify need and accessing services and resource to address needs.

# Service Category 2: Healthy Development

Healthy Development Programming follows evidence-based or evidence-informed practices that demonstrate success in supporting positive health behaviors and that drive better health outcomes for children from birth through five years, as well as expectant parents. Programming in this area will specifically focus on improving outcomes related to healthy births, child health, well-being, and ensuring children are developmentally on track. Programs will work in tandem or complement home visiting programming. (New recommendations have been noted in blue).

## Service Category 3: Parent Education and Support

This area focuses on parental support including parent education through home visiting, as well as ancillary support addressing the preventable causes of infant mortality. It also includes translation and interpretation services to ensure all parents have access to services and resources. As a result of services, expectant parents and parents will have access to the information, resources, and social support they need to be more confident and empowered to make informed choices for themselves, their children, and their families. ## Service Category 4: Early Learning

Early childhood research substantiates the rapid development of emergent literacy and language skills that occur in a child's first three years of life. In combination with key skills in the socio-emotional, physical, and cognitive domains, these skills are the foundation for lifelong learning beginning in kindergarten and continuing into subsequent school years. Programming in this area will ensure all children have access to quality early learning programming. Programs will be responsive to the varying circumstances and diverse families and children residing in Kent County.

The Ready by Five Evaluation is examining data collected by all programs funded with millage funds and will provide information about the impact of Ready by Five services on health and academic outcomes, including what types of services work, for whom, and under what conditions. The results will provide local early childhood leaders with information about the types of services that need to be retained or expanded in Kent County and evidence of impact on health and academic outcomes that contribute to the cost-effectiveness of early childhood services, as well as the overall community value of the Ready by Five Early Childhood Millage.

In September 2022, the RPRB recommended the allocation of resources that will be more readily available to agencies to apply for. These funds will further agency responsiveness to immediate need as well as support initiatives that specifically ensure young children and their family's voice are prioritized in Kent County in the coming year.

Funding was also allocated for programs already funded by Ready by Five to purchase computers costing above \$1,000 for staff working in Ready by Five funded programs. Since there are additional tracking requirements for technology equipment purchased with Ready by Five funding, technology above \$1,000 is not an allowable cost in the regular proposal request process.

Technology request recommendations by the RPRB have been noted in blue.
